Close the Gap Spotlight: Amanda Simington

It's not every day that you save someone's life! But thankfully Amanda Simington's passion, expertise, and quick judgment, helped her prepare for this important, life-saving experience.

Paralyzed with Guillain Barre Syndrome as a child, she was ventilated with a tracheostomy and had a gastrostomy tube. "The experience gave me appreciation for those with disabilities from a young age, and gratitude that I was able to enjoy a full recovery," recalled Amanda.

Amanda recently became one of the Program Supervisors at Howard House. Although she was still getting to know everyone in the home, she knew something was wrong

when the staff reported to her that one of the individuals was coughing when they drank. After notifying the nurse and guardian, she scheduled them for a swallow study, which revealed that they were silently aspirating. Thankfully, getting a g-tube placed fixed the issue!
