Campaign Hits 4-Year Milestone

When we embarked on our *Close the Gap* journey, we had no idea the impact it would have on our direct care staff. Initially, our goal was to raise \$150,000 to support our workforce, when we launched in the summer of 2019.

Thanks to you all, our generous donors, we quickly exceeded our expectations—by that fall, we had already hit our goal! When we hit the 2-year milestone in the summer of 2021, we decided to make this a 5-year campaign. We were two years into a global pandemic and the workforce shortage was not going away anytime soon—we needed to continue supporting our staff.

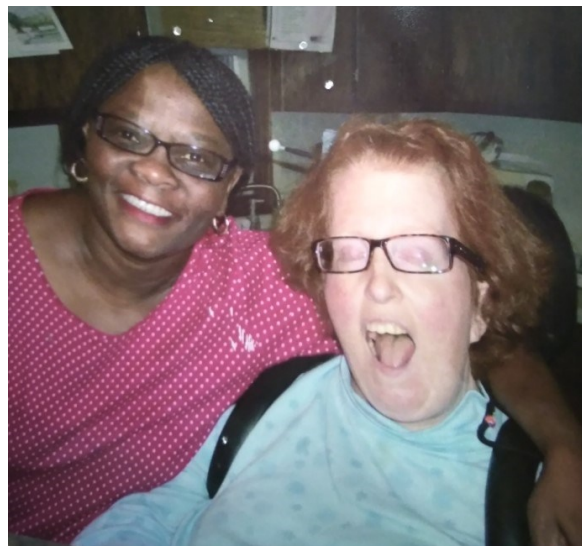
And we've been able to do just that! **Through June of 2023, we have raised \$917,626 for the campaign.** In 2021, we used our *Close the Gap* funds to give our direct care staff pay increases. *Close the Gap* continues to fund that increase. In 2022, we spent \$113,739 on these increases.

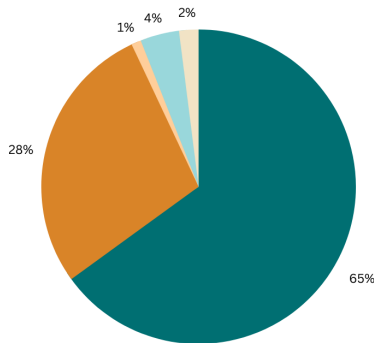

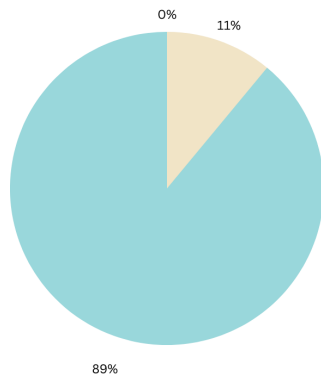

Transitioning to a New Home

At Phoenix Service Corporation, we specialize in helping vulnerable populations find the support and services they need to lead happy and fulfilling lives and sustain independent living. We do this through four programs to offer these vital services. Read on to learn more!

Housing Support Program

The Housing Support Program, formerly known as GRH, is a statewide program that assists individuals who are experiencing homelessness with housing and funds for room and board expenses. We work with individuals in Dakota, Hennepin, Ramsey, and Washington counties.

Through a grant provided by the county, the program pays for rent, utilities, and household supplies to help individuals transition from homelessness to stable housing over a period of 12 months.

In addition to financial assistance, participants meet with their Housing Support Specialist regularly to access essential every day resources, such as mental health and physician services, food shelves, and SNAP benefits.

Case Management

Our dedicated team of 17 case managers work with those we support to make informed decisions about the care they receive and help coordinate their support teams to ensure they are living in the most independent environment possible.

Clients receive waiver funding from the state and utilize their Case Manager's expertise to choose services tailored to meet the needs of their mental and physical disabilities.

“You’re working with a diverse caseload,” said Director of Community Services Megan Avakian, who oversees our Case Management services for 596 clients. **“From childhood to the elderly in completely different settings.”**

Housing Stabilization Services

While the Housing Support Program provides immediate assistance to individuals experiencing homelessness, our Housing Stabilization Services (HSS) focuses on long-term housing sustainability. We work with clients in planning for, finding, and moving into a home in the community.

HSS is designed to support clients who are having trouble maintaining housing stability due to factors such as eviction or difficulty working with their landlords. HSS consists of three phases: consultation, transition, and sustaining to find the best fit for them.

HSS is designed to meet people where they are in their moving process and provide person-centered support moving forward. This program is funded through Medical Assistance, as we receive referrals from case managers, outreach programs, and self-referred individuals.

Our primary goal at Phoenix Service Corporation is to help people achieve housing stability and ongoing care. By coordinating services, securing funding, and providing ongoing support, these programs work together to improve the lives of individuals with disabilities every day.

SUCCESS STORY

Jamal Taylor comes from a large family and was born and raised here in Minnesota. Jamal fell on hard times in his past and turned to alcohol and drugs. He lived in several shelters in Hennepin County before deciding to become sober, and eventually began receiving Housing Support services through Phoenix Service Corporation.

Jamal is grateful for what Phoenix has done to help him keep on track and stay sober. He appreciates that Phoenix helps him complete his paperwork, and keeps him up to date with his housing and county benefits. Jamal has worked with the same Housing Specialist, Alan Dale, since he began working with us in 2020.

“Alan is an excellent, calm, and cool guy who is always willing to help me problem solve issues that arise, and he always keeps his appointments,” said Jamal Taylor.

Jamal lives in a duplex with a roommate. Nearby, he has support from the Salvation Army community—attending several groups and has built good relationships with the people and pastor there. In his free time, Jamal enjoys collecting and listening to vinyl records from the ‘70s and ‘80s, especially smooth jazz music.

Transitional Services

Moving can be a stressful time for many people, and for those in our community, it's no different. To help with the burden, **Phoenix Service Corporation** began offering **transitional services** to make that move just a little bit easier. When the county expressed a need nearly 10 years ago, we jumped at the opportunity. Now, we support individuals moving anywhere within the state.

We provide support to individuals moving into their own home or an integrated community setting, who are receiving waiver services. Referrals are submitted through case managers. We then work with the individuals to coordinate the move and provide essential items needed to live independently.

We work with outside vendors to provide furniture and help with the move. We also shop for and provide household items for the individual, and help pay lease or rental deposits, additional moving expenses (e.g. vehicle rental, packing, unpacking), application fees, and utility set-up fees and deposits. The funding each person receives is limited, so we discuss their priorities and how to allocate the funding, based on their needs. Once the referral is complete, we are reimbursed by the state of Minnesota.

“I’m here to make a stressful time a little bit easier,” said Transitional Coordinator Jessica Lipnik. “I enjoy being able to provide that support and make it an easier process for them. We try to be accessible whenever we can.”

Whether an individual calls worried 10 mins after their delivery window opens because the movers aren't there, or they just want someone to talk to, we're happy to provide a helping hand...There have been times where I've called to confirm delivery time, and I'm on the phone for 20 minutes just talking to them because it's a stressful time,” said Jessica Lipnik.

As we always say, we keep Life Moving Forward.

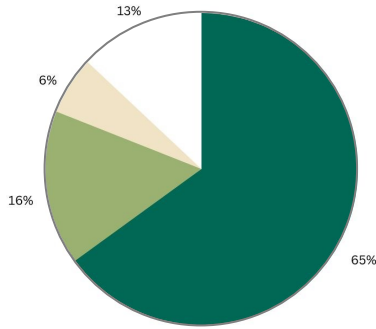

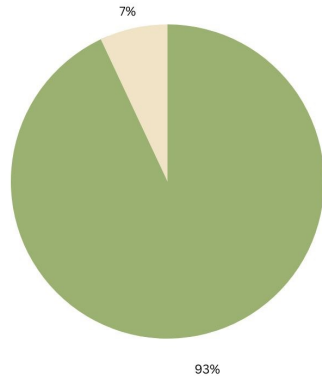
